Valid 4/1/2026 – 3/31/2027 & revised as vendors are added or removed (Current as of 3/25/2026)

**Event promoters/organizers should secure vendor services at least 30 days prior to event & inform Events Department about each vendor.**

Temp location vendors may provide service in all areas except those listed under *Permanent Location Exclusive Vendor* below.

- **Temp Concessions Service:** Food & non-alcoholic/alcoholic beverages purchased by customer from menu & payment collected from customer at point of sale.
- **Temp Catering Service:** Food & non-alcoholic/alcoholic beverages from limited menu provided for pre-determined number of patrons & single fee paid by event promoter/organizer.
- **Temp Concession Alcoholic Beverages:** Beer, wine, cider & spirits
